

SUMMARY ANNUAL REPORT

This is a summary of the annual report of the American Dairy Queen Corporation Health Plan, EIN 41-0853275, Plan No. 550, for period 01/01/2024 through 12/31/2024. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

American Dairy Queen Corporation has committed itself to pay certain self-insured Medical, Stop Loss, Dental, and Short-term Disability claims incurred under the terms of the plan.

Insurance Information

The plan has contracts with Eyemed Vision Care On Behalf Of Fidelity Security Life Insurance Co., Pre-paid Legal Services Inc dba Legalshield, Telus Health (us) Ltd., Zurich American Insurance Company, Unum Life Insurance Company Of America to pay Vision, Life Insurance, Long-term Disability, Accidental Death and Dismemberment, Employee Assistance Program, Business Travel Accident, Legal, Critical Illness, Hospital, and Accident claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2024 were \$509,392.
