

## Summary Annual Report

### For Beth Israel Deaconess Hospital - Plymouth Hospital 403(b) Retirement Plan

This is a summary of the Form 5500 Annual Return/Report of Employee Benefit Plan for the Beth Israel Deaconess Hospital - Plymouth Hospital 403(b) Retirement Plan, Employer Identification Number 22- 2667354, Plan No. 002 for the period January 1, 2024 through December 31, 2024. The Form 5500 annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA). Your plan is a Single-Employer defined contribution plan with the following characteristics: 403(b) Annuity Contract, 403(b) Regulated Investment Company Stock, Default Investment Account, Directed Brokerage Accounts, ERISA Section 404(c), Member of Controlled Group, Participant-Directed.

### Basic Financial Statement

Benefits under the plan are provided through insurance and through a trust fund. Plan expenses were \$25,592,366. These expenses included \$177,952 in administrative expenses and \$25,353,010 in benefits paid to participants and beneficiaries and \$61,404 in other expenses. The plan was merged into the Beth Israel Lahey Health 403(b) Retirement Savings Plan as of December 31, 2024. Therefore, there were no participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$0, as of December 31, 2024 compared to \$198,294,609 as of January 01, 2024. During the plan year, the plan experienced a decrease in its net assets of (\$198,294,609). This decrease includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$37,523,153, including employer contributions of \$3,092,891, employee contributions of \$9,914,064, other contributions of \$3,011,386, and earnings from investments of \$21,504,812.
