

## **SUMMARY ANNUAL REPORT**

### **For Wellsky Health And Welfare Plan**

This is a summary of the annual report of the Wellsky Health And Welfare Plan, EIN 11-2209324, Plan No. 501, for period 01/01/2024 through 12/31/2024. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Wellsky Corporation has committed itself to pay certain self-insured Medical, Dental, and Short-term Disability claims incurred under the terms of the plan.

### **Insurance Information**

The plan has contracts with Vision Service Plan, Curalinc, Llc, D.b.a Curalinc Healthcare, Reliastar Life Insurance Company, Lincoln National Life Insurance Company to pay Vision, Life Insurance, Long-term Disability, Accidental Death and Dismemberment, Employee Assistance Program, Critical Illness, Hospital, and Accident claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2024 were \$1,660,842.
