

**SUMMARY ANNUAL REPORT
FOR
THRIFT PLAN FOR EMPLOYEES OF VISITING NURSE ASSOCIATION OF MIDDLESEX EAST (VNAME)**

This is a summary of the annual report for the Thrift Plan for Employees of Visiting Nurse Association Of Middlesex East (VNAME), EIN 20-1287349, Plan No. 002, for the period January 1, 2024 through December 31, 2024. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided through insurance and a trust fund. Plan Expenses were \$1,087,403. These expenses included \$1,069,919 in benefits paid to participants and beneficiaries, (\$384) in certain deemed distributions of participant loans, \$0 in corrective distributions and \$17,868 in other expenses. A total of 69 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$8,035,740 as of December 31, 2024, compared to \$7,983,781 as of January 1, 2024. During the plan year the plan experienced an increase in its assets of \$51,959. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$1,139,362 including rollover contributions of \$0 and earnings from investments of \$1,139,362.
