

SUMMARY ANNUAL REPORT FOR FIVE STAR SENIOR LIVING INC. BENEFITS PLAN

This is a summary of the annual report of the FIVE STAR SENIOR LIVING INC. BENEFITS PLAN (Employer Identification Number 04-3516029, Plan Number 501) for the plan year 10/01/2022 through 09/30/2023. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

ALERISLIFE INC. has committed itself to pay certain Health, Prescription drug, Flexible spending account, Health reimbursement arrangement claims incurred under the terms of the plan.

Insurance Information

The plan has insurance contracts with VISION SERVICE PLAN, LIFE INSURANCE COMPANY OF NORTH AMERICA, METROPOLITAN LIFE INSURANCE COMPANY and EMPLOYEE & FAMILY RESOURCES, INC. to pay certain Vision, Life insurance, Temporary disability, Long-term disability, Accidental death and dismemberment, Dental, Employee assistance program claims incurred under the terms of the plan. The total premiums paid for the plan year ending 09/30/2023 were \$3,177,535.
