

SUMMARY ANNUAL REPORT FOR SAGP 401(K) RETIREMENT PLAN

This is a summary of the Form 5500 Annual Return/Report of Employee Benefit Plan for the SAGP 401(K) Retirement Plan, EIN 04-3485648, Plan 001, for period January 1, 2024 through December 31, 2024. The Form 5500 annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA). Your plan is a defined contribution, profit-sharing, ERISA section 404(c), total participant-directed account, Code section 401(k), Code section 401(m), default investment account, pre-approved, controlled or affiliated service group member, single employer type of plan.

Basic Financial Statement

Benefits under the plan are provided through insurance and through a trust fund. Plan expenses were \$1,000,591. These expenses included \$26,768 in administrative expenses and \$973,823 in benefits paid to participants and beneficiaries. The plan terminated as of December 31, 2024. Therefore, there are no participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$0 as of December 31, 2024, compared to \$12,334,961 as of January 1, 2024. During the plan year, the plan experienced a decrease in its net assets of (\$12,334,961). This decrease includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$1,894,198, including employer contributions of \$189,091, employee contributions of \$523,286, other contributions of \$25,949 and earnings from investments of \$1,155,872.

A total of \$13,228,568 was transferred out of the plan to Beth Israel Lahey Health 401(k) Retirement Savings Plan.
