## FLEXIBLE SPENDING & HEALTH REIMBURSEMENT ACCOUNT REMINDERS

#### Healthcare Flexible Spending Account Claims and Carryover

If you were enrolled in Dependent Care and/or HealthCare FSA in 2022, you have until March 31, 2023 to file claims incurred between January 1 and December 31, 2022. Powell's HealthCare FSA has a \$550 carryover provision if you enrolled during Annual Enrollment 2023. Any funds above \$550 for the 2022 plan year that have not been claimed will be forfeited. The carryover takes place in April.

#### **Health Reimbursement Account Claims and Rollover**

If you were enrolled in either the Basic or Premier CDHP plan in 2022, you have until March 31, 2023 to file claims incurred between January 1 and December 31, 2022. Powell's HRA rollover and account balance maximum is located below and only applicable if you continued enrollment in a CDHP plan for 2023. The rollover took place in January.

#### HealthCare FSA (HFSA)/Health Reimbursement Account Coordination

If you enrolled in the Healthcare FSA and Basic or Premier CDHP health plan, your HFSA funds will be used before your HRA funds.

- HFSA funds can be used for eligible expenses for any of your eligible dependents
- HRA funds can be used for eligible expenses for dependents enrolled on your basic or premier medical plan
