Participate in the 2026 Healthy Hillman Wellness Program and earn a Healthy Hillman discount rate on your 2027 insurance premiums. This guide will help you understand how to earn the medical premium discount rate.

This wellness program is offered to all employees. Only employees and spouses enrolled in a Hillman medical plan are eligible to receive the incentive.

Specifics on Your 2026 Program

Complete Your Biometric Screening with Nicotine Test

Onsite biometric screenings will be offered to employees at participating Hillman locations in April, May and June. Offsite screenings are available at LabCorp or your physician's office. Participants will need to register each year for their screening at hillman.mywellportal.com. Offsite screenings require the 2026 screening form to be taken to the lab or physician's office. Prior-year forms will not be accepted. The 2026 form can be found at hillman.mywellportal.com. **The deadline to complete your annual screening by June 30, 2026.** Biometric Screening credit will be awarded to your Healthy Hillman portal within 15 days of completing a biometric screening.

Confirm Screening Results

After completing the biometric screening, which includes the nicotine test, participants need to confirm if they met 3 out of 5 healthy outcomes criteria and are tobacco-free. Screening results data will be available on the portal within 15 days of completing the screening.

To view your health status:

Scroll down the homepage to '**Health Status**'. If you achieved 3 out of 5 healthy outcomes, you will see a green check mark that says you achieved this goal and are not required to take any additional action. If you did not meet 3 out of 5 healthy outcomes, you will see a red X that says you did not achieve the goal and/or did not pass the nicotine test.

Meet 3 of 5 Healthy Outcomes Criteria and be Tobacco-Free:

- Total Cholesterol: <200 mg/dL or 5% improvement
- HDL Cholesterol: Men >40 mg/dL; Women >50 mg/dL or 5% improvement
- Triglycerides: <150 mg/dL
- Fasting Blood Glucose: <100 mg/dL or 5% improvement
- Blood Pressure: <130/85 mm Hg or 5% improvement

RAS –Coaching or Medical Waiver

Individuals who do not meet 3 of 5 healthy outcomes criteria or test positive for tobacco can earn the Healthy Hillman discount by completing a 4-week health coaching program or providing a physician's medical waiver to Marquee Health as a Reasonable Alternative Standard (RAS). You may contact a Marquee Health Coach by emailing coaching@mywellportal.com or by calling **800.882.2109** and reference '**Hillman Group**' to schedule your first coaching session. Connect with a confidential health coach by email or by phone. **Register for the coaching program by July 31, 2026, and complete 4 sessions by September 11, 2026.** Tobacco free credit and Healthy Outcomes credit will be awarded to your Healthy Hillman portal within 15 days of completing a biometric screening or 4-week health coaching program.

2026 New Hires

Important details:

- Benefits Eligibility – Employees are eligible for Hillman health benefits the first of the month following their hire date (or on their hire date if hired on the first of the month)
- Employees hired after Dec. 31, 2025, are not required to meet healthy outcomes, be tobacco free or complete a reasonable alternative standard if they complete a screening within 60 days of benefit eligibility. Those who miss the 60-day window, but still screen before the current program's June 30, 2026 deadline, will need to meet healthy outcomes and be tobacco free, or complete the alternatives as described in this guide.
- The 2026 medical premium discount will be applied once the biometric screening is filed as complete by Marquee Health. Marquee manages all confidential wellness data to keep it separate from employment information. Discounts will be applied in the pay period during which Hillman is notified of successful completion by Marquee.

How do new hires log in to the Healthy Hillman Portal?

- It can take up to two weeks from hire to access the Healthy Hillman portal.
- Visit hillman.mywellportal.com or download the MyWellPortal app. Then log in with credentials in the following format:

Employee Username: 'hillman' + EEID (Ex: *hillman123456*)

Spouse Username: 'hillman' + EEID + S (Ex: *hillman123456S*)

Password: DOB (MMDDYYYY)

Program FAQs

Why don't I receive credit right away for some activities?

Certain activities must be administratively verified by Marquee Health for accuracy. Our team works as quickly and efficiently as possible to award credit in a timely manner, however, it can take up to 30 days for activities to be reflected within your account.

Why do activities state 'Not Completed', 'In Progress' or 'Completed'?

You will see a completion status next to each activity, dependent on how many times you can log the activity and if anything has been logged to date. 'Not Completed' means nothing has been logged for that activity; 'In Progress' means that you have logged some and can still log more to reach the point maximum for that activity (for example, you may have logged 1 out of 3 available preventive care visits). 'Completed' means that you have logged the maximum allotted for that activity.

Why is there a deadline to enroll in a coaching program?

Each telephonic or email coaching program consists of 4 weekly sessions with your dedicated health coach. In order to complete your program before the September 11, 2026 deadline, you must enroll by July 31, 2026 to allow enough time to complete the 4 sessions.

I have a spouse covered on my medical plan. Do both of us have to participate to earn the Healthy Hillman discount rate?

Yes! To qualify for the Healthy Hillman discount rate, both the employee and covered spouse must complete all required activities in this guide by the deadline.

Do both employee and spouse need individual accounts?

Yes! To track your own participation in the Healthy Hillman program and be eligible for incentives, you and your eligible spouse must follow the directions on the first page of this guide to log in to your own personal account.
