

## **SUMMARY ANNUAL REPORT**

### **For BETH ISRAEL LAHEY HEALTH, INC. EMPLOYEE BENEFITS PLAN**

This is a summary of the annual report of the BETH ISRAEL LAHEY HEALTH, INC. EMPLOYEE BENEFITS PLAN, EIN 83-2671600, Plan No. 501, for period 01/01/2023 through 12/31/2023. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

BETH ISRAEL LAHEY HEALTH, INC. has committed itself to pay certain self-insured Medical claims incurred under the terms of the plan.

### **Insurance Information**

The plan has contracts with EYEMED VISION CARE ON BEHALF OF FIDELITY SECURITY LIFE INSURANCE CO., ARAG INSURANCE COMPANY, DENTAL SERVICE OF MA, INC DBA DELTA DENTAL OF MA, RELIASTAR LIFE INSURANCE COMPANY, THE GUARDIAN LIFE INSURANCE COMPANY OF AMERICA, FEDERAL INSURANCE COMPANY, PRUDENTIAL INSURANCE COMPANY OF AMERICA, KGA INC, and UNUM LIFE INSURANCE COMPANY OF AMERICA to pay Dental, Vision, Life Insurance, Short-term Disability, Long-term Disability, Accidental Death and Dismemberment, Employee Assistance Program, Business Travel Accident, Legal, Critical Illness, Hospital, and Accident claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2023 were \$147,351,687.
